## Forced migration in a comparative life-course perspective

Forced migration is globally increasing in volume, types and contexts. Although legal and political action oriented approaches by UN and other international agencies are important, they are not sufficient for covering a growing part of forced migration. Going beyond the classic concept of refugees, we understand forced migration as change(s) of residence as taken-for-granted everyday life pushed by a considerable subjective and objective degree of enforcement and life-threatening caused by persecution because of racial, religious, ethnic, political, national or gender reasons or based on life threatening disasters or catastrophes.

Sociological expertise can help to understand and explain such dynamics by conceptualising forced migration as a protracted iterative social process of individual and collective action under life-threatening restrictions in institutionalised social contexts. This suggests a longitudinal and mixed methods approach integrating from local to transnational levels. Life-course research combines trajectories (as objective sequences of social positions and events in time) with biographies (as subjectively experienced and remembered flow of social practice and incidents). For forced migration, a general focus is on (1) the period in the life course before moving, (2) the often long lasting period of migration itself, and (3) the phase after arrival at or return to a safe and aspired place.
